**MINUTES OF JANUARY 8, 2015

**OPEN SESSION**

1. Call to Order and Pledge of Allegiance.

Chairman Lopes recognized the passing of former Division of Law Enforcement Director Glenn Craig. Mr. Craig was a long time Department of Justice employee. During his law enforcement tenure, he was elected the Sheriff of Sacramento County for approximately twelve years. As well as, the Commissioner of the California Highway Patrol. Chairman Lopes went on to say he was a friend and mentor. Glenn Craig died at the age of eighty one.
